(1)	Membership Application Form	
i.	The Trade name of the Applicant and name of Managing Partner mentioned in the application should match in all the documentation.	
ii.	All the pages of the Application form are to be signed by the authorised signatories.	
iii.	Last Page –Date of making an application to be mentioned AND Place to be given.	
iv.	Last Page – Specimen of the signature(s) under the rubber stamp of the firm/ authorized signatories should be provided along with the Name and designation of the signatories. Photographs of the Managing Partners should be affixed and signed across.	
(2)	PAN Details and GST Details	
i.	Applicant name should match with the legal or trade name mentioned in PAN and Trade name in GST Certificate.	
ii.	Certified Copy of the PAN Card (Both Sides) of the member signed by authorised signatories.	
iii.	Certified Copy of GST Registration Certificate of the member signed by authorised signatories.	
(3)	Proof of Address of the Applicant	
i.	Is the applicant Indian National /Registered in India	
ii.	The copy of the address proof submitted is self certified under the rubber stamp.	
iii.	The address proof submitted is valid (i.e. validity of the documents should not expire.)	
(4)	Bio- data	
i.	Bio data submitted for Managing Partners who have signed the Application Form and in the prescribed format of the Exchange.	
(5)	Brief History of the Applicant	
i.	Submitted on the letterhead of the Applicant and certified by authorised signatory under the rubber stamp of the firm.	
(6)	Firm Registration Certificate	
i.	The firm registration certificate submitted as certified true copy by the authorized signatory under the rubber stamp of the firm.	
ii.	The name of member and date of registration mentioned in the certificate matches with the name of the member and date of registration mentioned in the application form.

(7)	Registered Partnership Deed	
i.	The Registered Partnership Deed submitted is certified as true copy by the authorised signatory under the rubber stamp of the firm.	
ii.	The Registered Partnership Deed submitted should include the business of trading of power, energy, and related products. (only applicable for Facilitator member category)	
(8)	Sharing Pattern	
i.	Sharing Pattern submitted is in the prescribed format of the Exchange and on the letterhead of the Firm.	
ii.	Sharing Pattern submitted is certified by authorized signatories under the rubber stamp of the firm.	
iii.	Sharing Pattern submitted is certified by Chartered Accountant/Company Secretary along with rubber stamp of C.A. / C.S. Firm, UDIN No. and Membership number.	
(9)	Undertaking from all the Partners Authorizing Managing Partners	
i.	The Undertaking is in the prescribed format of the Exchange and on the letterhead of the firm.	
ii.	The Undertaking contain name of all the partners and signature of all the Partners.	
(10)	Networth Certificate	
i.	Submitted in Method 1 /Method 2	
ii.	Networth Certificate submitted is in the prescribed format of the Exchange and on the letterhead of the Chartered Accountant and certified by him.	
iii.	Networth Certificate submitted is not more than 6-month-old.	
iv.	The details of the Chartered Accountant such as Name of the firm, name of the Proprietor/ Partner signing the certificate, rubber stamp, UDIN No. and Membership No. of the Chartered Accountant is mentioned in the Networth Certificate submitted. Digitally signed certificate is also acceptable.	
(11)	Latest Annual Report	
i.	Certified true copy of the Annual Report Submitted. Annual Report contains : a) Auditors Report b) Balance Sheet c) Profit & Loss A/c d) Schedule and Notes to the A/c	
(12)	Membership Undertaking on Rs.300/- Stamp Paper	
i.	Membership Undertaking should type and duly notarized and in the format approved by the Exchange.	
ii.	Execution date mentioned in the Undertaking is after the date of the Non-Judicial Stamp Paper or date of Franking.	
iii.	Each Page of the Undertaking is signed by the Authorized Signatory under the rubber stamp of the company as per exchange format.	
iv.	Authorized Signatory has signed next to every hand written details in the Membership Undertaking and attested under the rubber stamp of the company.	
v.	The Undertaking is witnessed by two persons along with the details such as name and address of witness.	
vi.	The Common seal of the company is affixed on the last page of the Undertaking in case of a Corporate member.
